The Leaf Valeo's high resolution ensures clean images and maintains high quality even with enlargements. We have produced images with this system that were printed as marquis posters with extraordinary detail.

Our new Leaf Valeo digital camera system enables you to view the images immediately upon capture on a large computer screen. There's no need view images on the LCD screen on the back of a camera or wait for images to be downloaded. Depending

upon the number of images required, the time of day of the shoot and your authority to make image selection decisions, unretouched image files can feasibly be processed and delivered on CD the same day. Another benefit with digital capture is to produce web preview pages of the photo shoot giving many people in different locations - agents, directors, clients and friends - to view proofs and make image selections worldwide at the same time.

All jpeg's must retain the copyright embedded in the image as delivered. Copyright remains with Bob Moynihan and can not be transferred, sold or given away.
- Photographic prints for your print portfolio.
- All files delivered include retouching. Retouching provides an age-appropriate, cover model appearance and includes removal of stray hair, eliminating large pores and blemishes, minimizing or eliminating scars, facial wrinkles and circles under eyes, whitening eyes and teeth and softening of skin to enhance your complexion.
- Assistance with wardrobe selection and posing are provided.

Professional make-up and hair styling can be provided at additional cost.

Bob Moynihan's 1500 square foot studio with 18 foot high ceilings provides ample room for inclusion of special props or creative techniques. Models may request photographs with props they can provide that will illustrate their unique talents, capabilities or characteristics.

All modeling portfolio assignments are accepted subject to the terms and conditions below and the rights and license granted are limited as follows;

- 1) **Parties and Assignment:** All agreements are between Bob Moynihan (author of the photographs) and the client (commissioning party and its agents). All assignments will be the photographer's interpretation rather than a literal recreation of client's concept(s) and/or layout(s).
- 2) **Quoted Fees and Expenses:** Apply to the original quote. Additional compensation must be negotiated with Bob Moynihan for any subsequent changes, additions or variations requested by the client. Client will be bound by oral authorization for fees or expenses which cannot be confirmed in writing due to the immediate proximity of the shoot. Quoted prices are valid for 30 days, otherwise, prices are subject to change at anytime.
- 3) **Cancellations and Postponements:** Waiting time is billed the same as creative time. Scheduled photographic appointments which are cancelled without a 48 hour notice are billed at 50% of the photographer's fee. If the client specifies weather conditions for the shoot and postponement is made prior to departure to location, client will be billed 50% of the photographer's fee. In the event of cancellation or postponement of the booking for any other cause than the photographer's, the client will be billed for all expenses incurred by Bob Moynihan.
- 4) **Client Representative:** Client is responsible for presence of its authorized representative at the shoot to approve Bob Moynihan's interpretation of the assignment. If no such representative is present, the client shall accept Bob Moynihan's interpretation of the assignment.
- 5) **Overtime:** In the event that a shoot extends beyond eight consecutive hours, Bob Moynihan may charge overtime for assistants and freelance staff at the rate of one-and-one-half times their hourly rate.
- 6) **Reshoots:** a) If digital image files become lost or damaged due to equipment malfunction or other technical error prior to delivery, Bob Moynihan shall reshoot without an additional fee and client shall pay all expenses for the reshoot. b) Client requested changes in completed shoots are subject to additional fee plus all additional expenses.
- 7) **Copyright:** Bob Moynihan retains the copyright to all images and artwork and descriptions thereof. The client is granted license or reproduction rights as determined in writing. For Non-editorial use, client will provide copyright protection by placing proper copyright notice on any use. Proper notice is "© Year, Bob Moynihan" adjacent to or within the photograph(s). For Editorial use, credit line in the form "© Year, Bob Moynihan" must appear adjacent to or within the photograph(s) or fee is tripled; Client acknowledges that such a triple fee is fair and reasonable for photographer's loss of recognition and lack of copyright protection resulting from lack of, or improper, copyright notice/credit line.
- 8) **Grant of Rights:** Grant of any reproduction rights is conditional upon receipt of payment in full and proper use of mutually agreeable copyright notice. All rights not expressly granted remain the exclusive property of Bob Moynihan. Unless otherwise agreed upon in writing, duration of the grant of rights is five years from invoice date and limited to use in the United States.
- 9) **Alterations and Derivative Works:** Client will not make or permit any alterations, additions, subtractions in respect to the photographs, including without limitation any digitization or synthesization of the photographs, alone or with any other material, by use of computer or other electronic means or by any other method or means now or hereafter known, unless otherwise agreed upon in writing.
- 10) **Payment:** Invoices are payable upon receipt and 2% per month finance charge is applied on any unpaid balance after 30 days unless otherwise agreed upon in writing. All projects that remain inactive for a period of 30 days will be considered complete and are billable and payable.
- 11) **Collection:** The terms of this agreement shall be governed by the laws of the State of New Hampshire and applicable Federal Copyright laws. Collection of indebtedness or enforcement of terms through an attorney at law will entitle Bob Moynihan to collect attorney's fees and all court costs.
- 12) **Indemnity:** The client will indemnify Bob Moynihan, his heirs and legal representatives against any claims and damages, including reasonable counsel fees, arising from the client's use of the photographs.
- 13) **Miscellaneous:** Client may not assign or transfer the rights granted in this agreement. Any modification of the terms must be in writing. Client is responsible for obtaining necessary permission for use of the photograph(s). The terms of this agreement shall be governed by the laws of the State of New Hampshire.
